1. Who was allocated social rented housing?

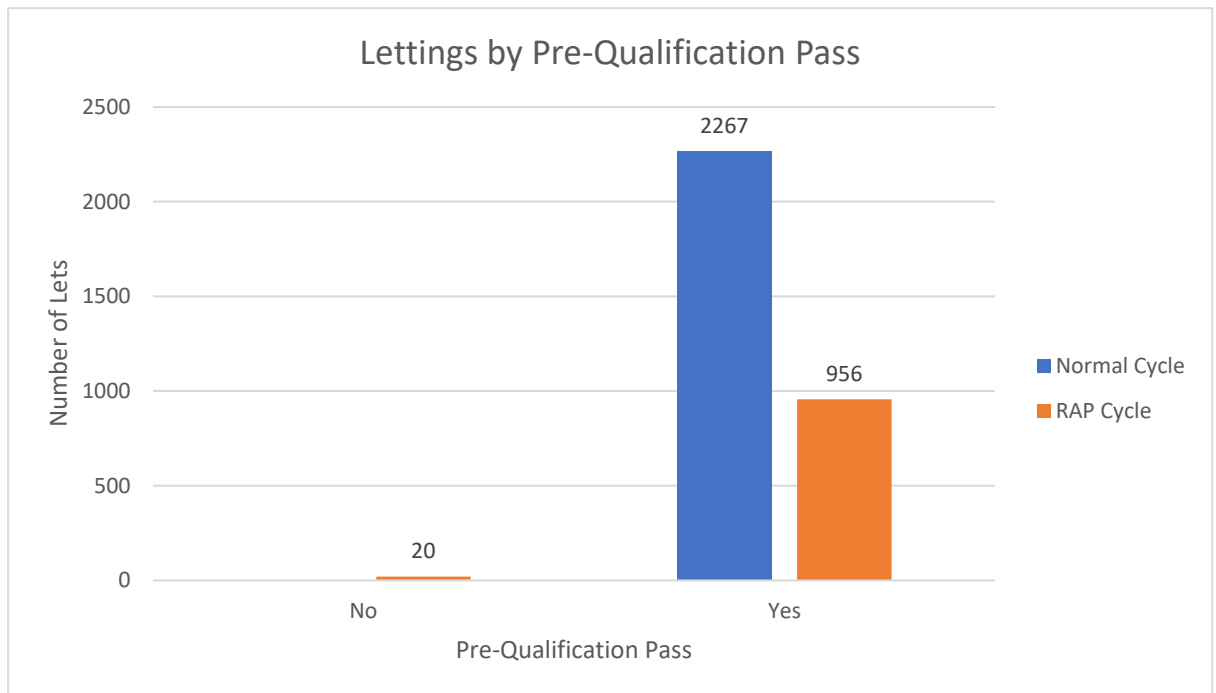
a) Characteristic (e.g. age, gender, household formation etc)

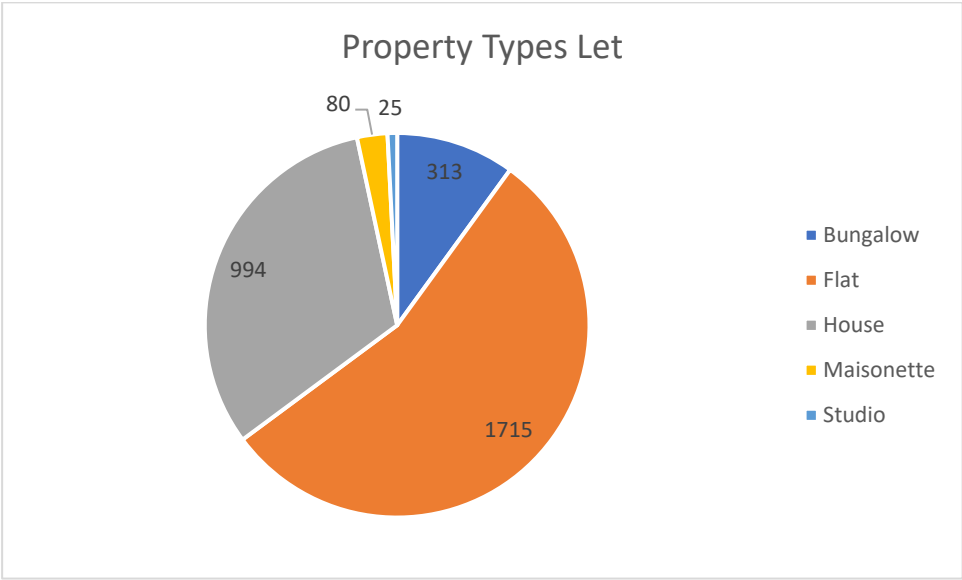
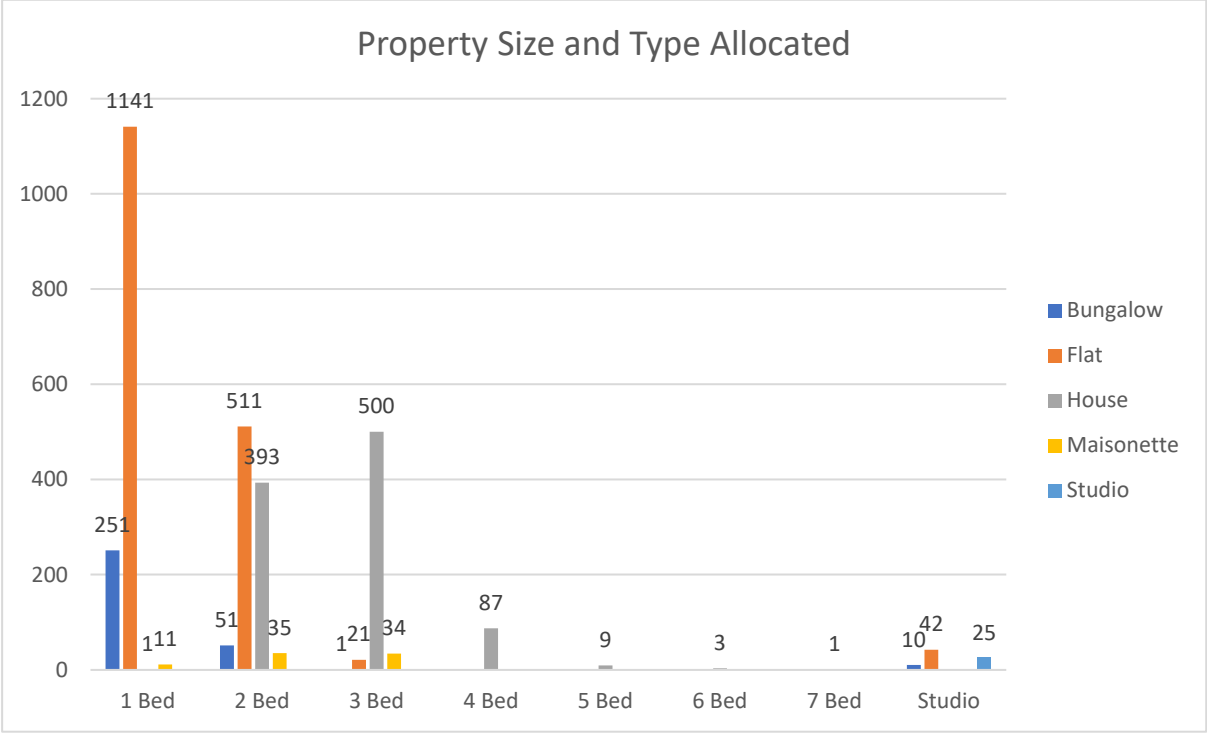


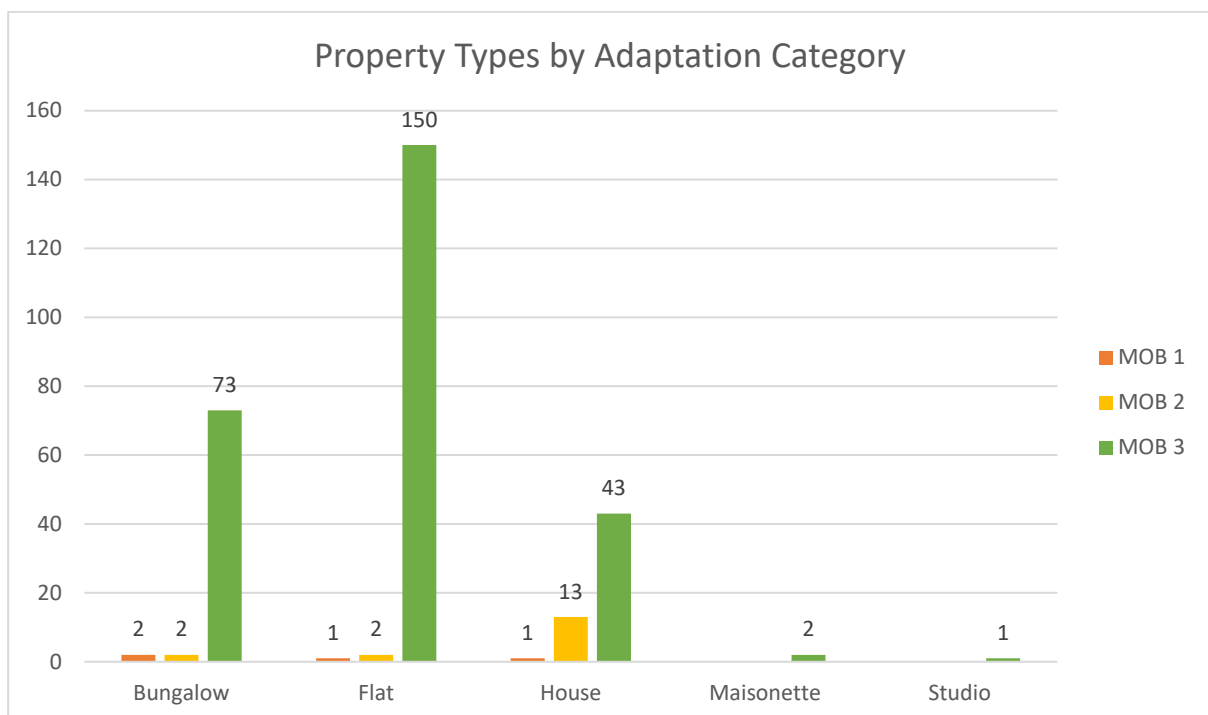
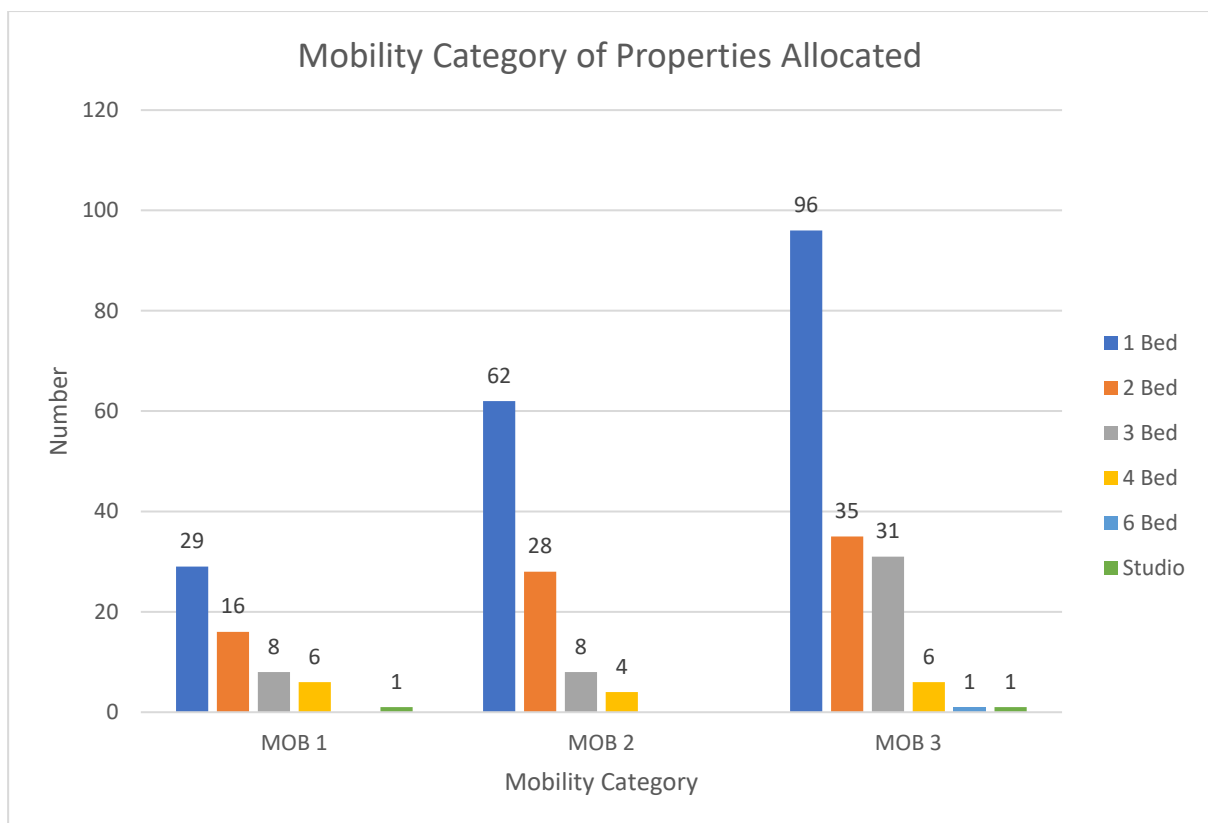
2. What social rented housing was allocated?

a) Number of bedrooms

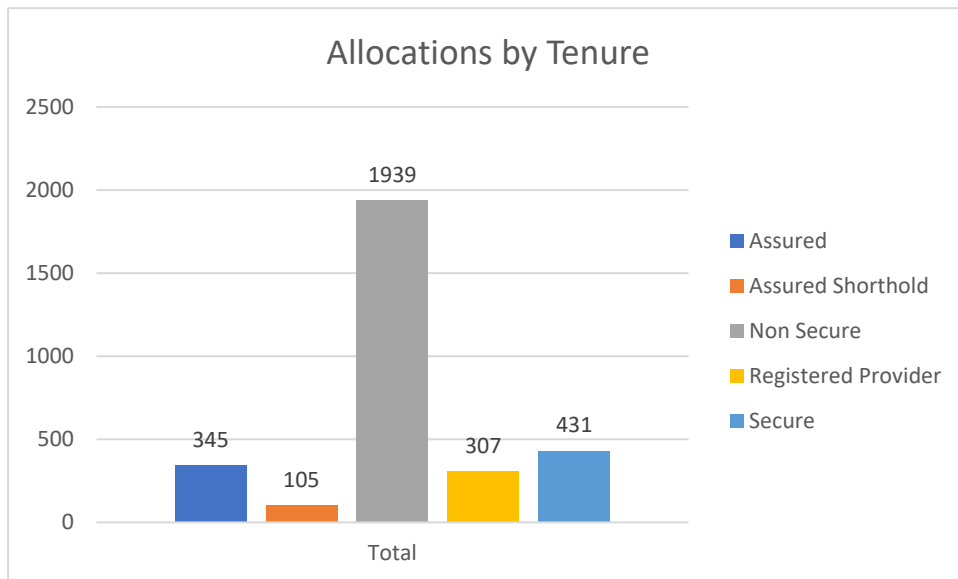


b) Property types

Band D (Inc Band 4) = 167 days

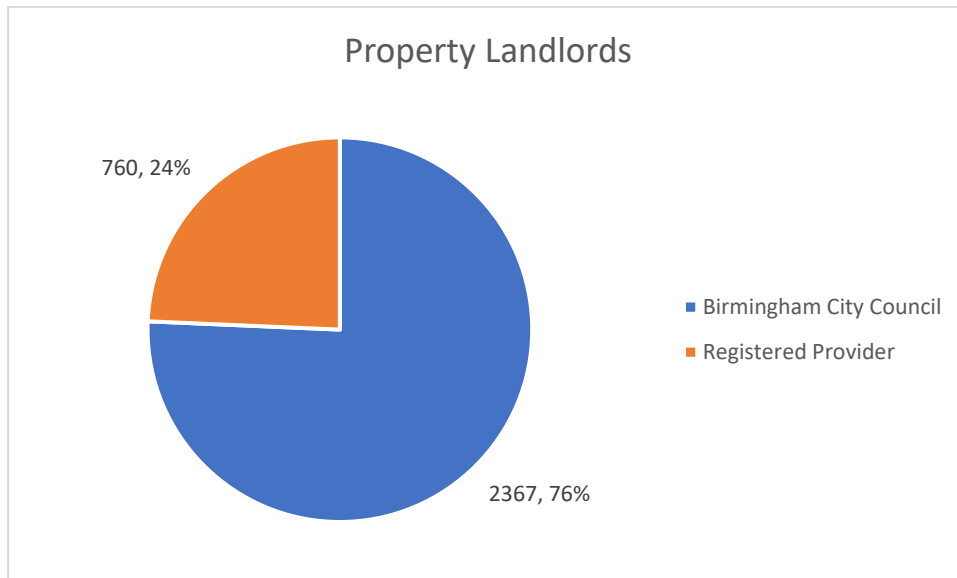

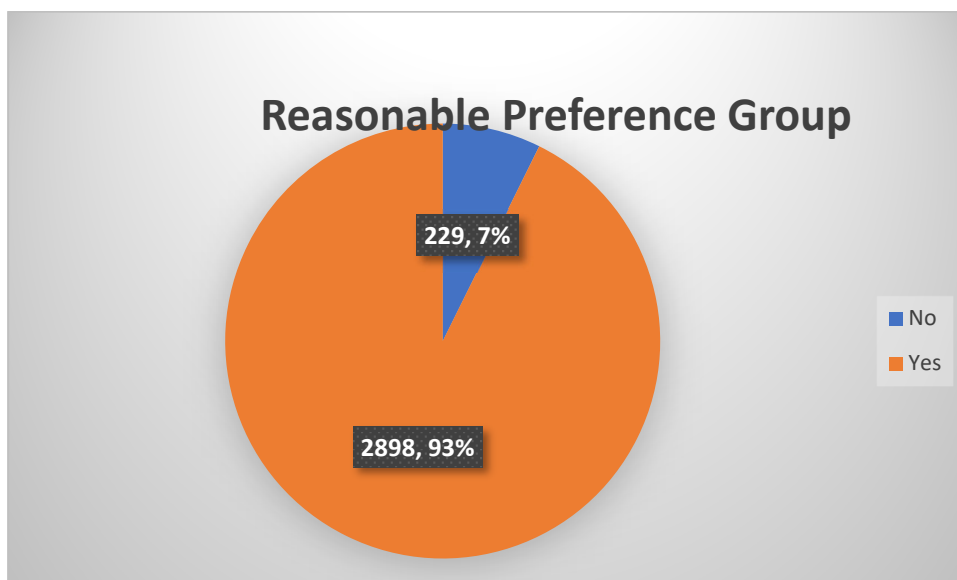

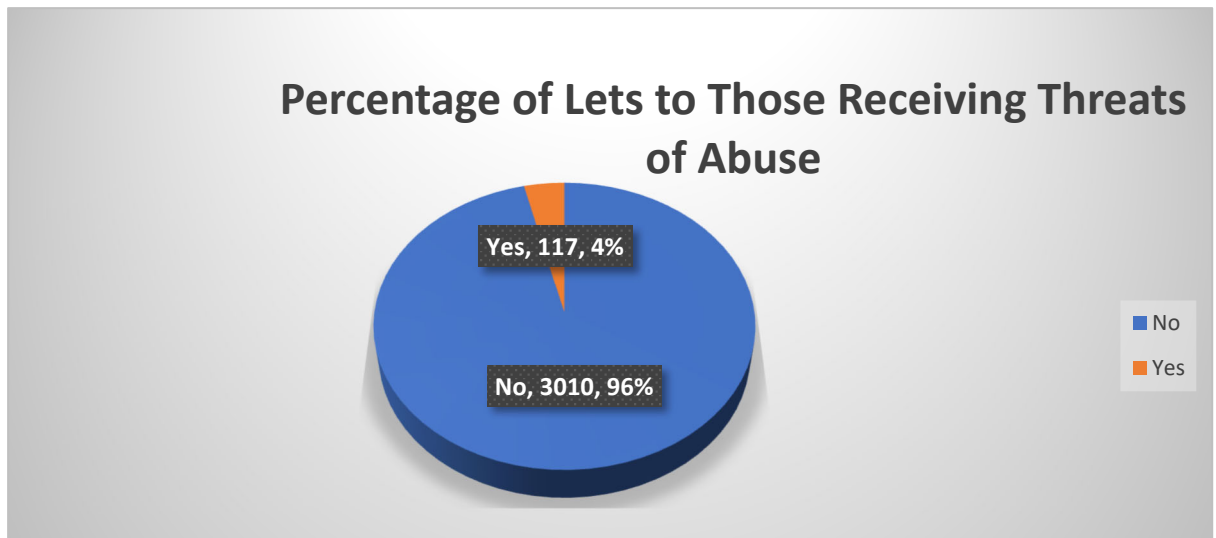


6. Why was social rented housing allocated

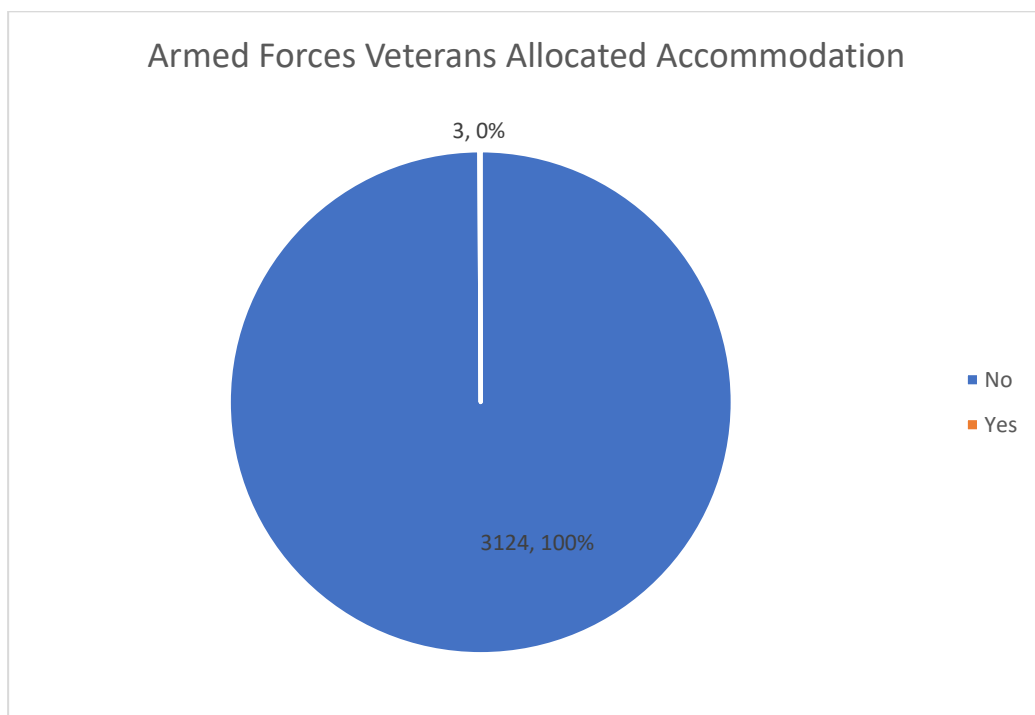
a) Reasonable preference

- d) Local connection – Total number of applicants allocated

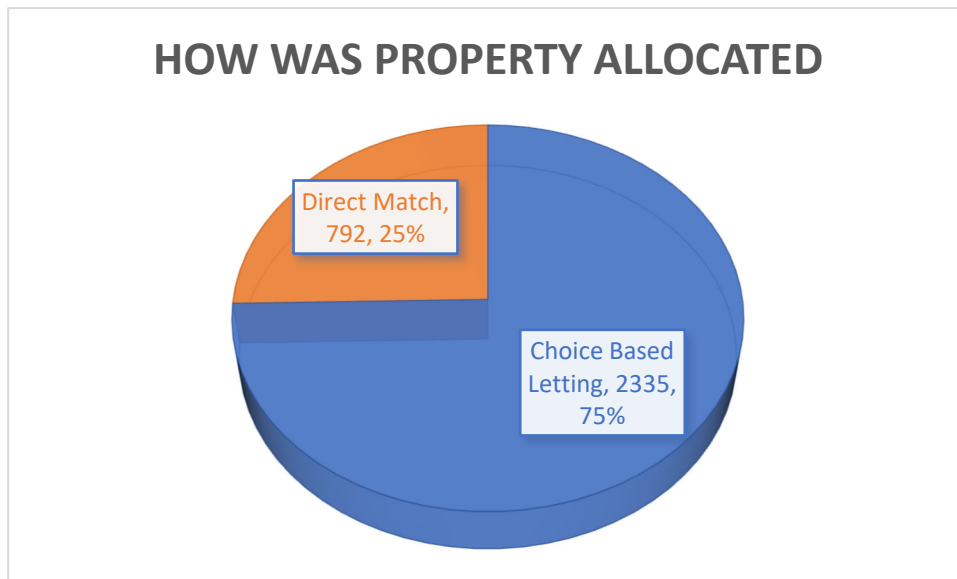

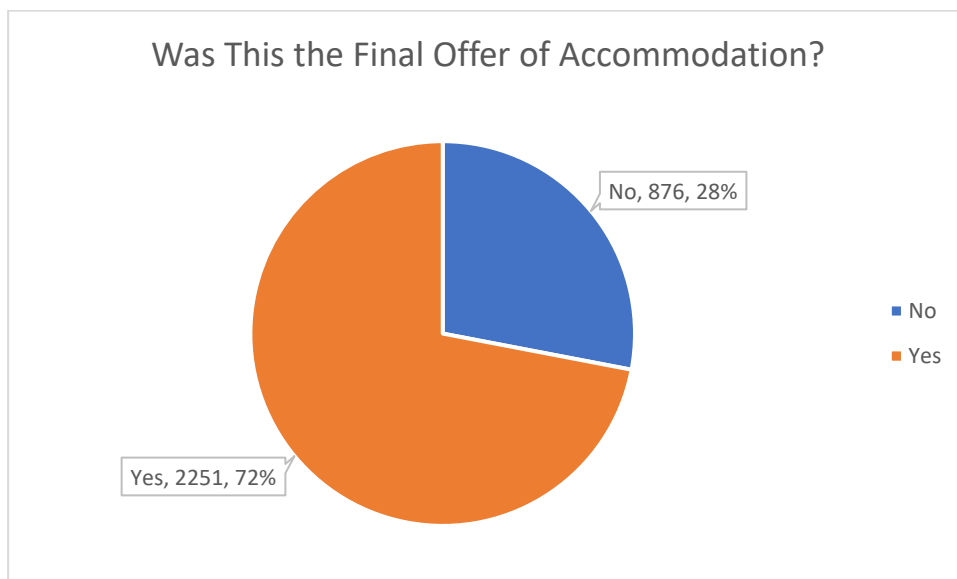
